I have also developed good relational skills with the representatives of institutions, associations and organizations, in terms of planning of the research and negotiating with stakeholders for accessing the research fieldwork. Thanks to my professional experience in the field of perpetrators treatment, I learned to involve different types of subjects in the commitment to common goals and in sharing their stories, thanks to the acquisition of empathic listening skills but also of determination and fairness in conducting group discussions.

Organizational and management skills

I have acquired excellent organizational and management skills thanks to the collaborations carried out during my teaching&research experience in several universities and research centres, where I designed and implemented educational and research projects. Thanks to the numerous research and professional collaborations I have learned to work in teams building effective relationships with both colleagues and supervisors. Often in team work I tend to take on the role of reporting the overall view of the various project articulations, stressing the importance of the division of tasks for an effective integration of roles in order to better conclude the activities or the project. I am accustomed to solving organizational issues and unforeseen problems due to the management and relational complexity of projects and teamwork, finding solutions and strategies capable of both enhancing existing skills and resources and identifying those necessary to achieve the desired results. I have good listening and mediation skills which I consider fundamental for the organization of team work and for facilitating the integration of complementary skills.

Professional skills

During the course of my studies and research I developed good theoretical and methodological skills that allowed me to open and develop autonomously different trajectories of investigation in the field of gender studies and in particular gender-based violence from the theoretical, methodological and operational point of view. In particular, the relationship between academic research and teaching,

training and social work as CAM practitioner has provided me with the interdisciplinary tools necessary to build and continuously update the knowledge of the phenomenon and the perspectives of the actors involved at all levels.

I acquired good theoretical basis in the field of sociology of law, critical criminology and gender studies, specializing in feminist theoretical perspectives on law, institutional policies, communication and social movements.

My main fields of study and research are: criminalisation and victimisation processes; gender violence and social security; prostitution, trafficking and sex work; sexual citizenship and LGBTQIA+ rights; prison and gender; intersectionality; methodologies of treatment of perpetrators of gender violence; norms, policies and public discourse on gender violence, prostitution and LGBTQIA+ rights. In these fields I developed good methodological skills for planning and research, in particular in the organization and management of the research field (mapping, contacts, organization and conduct of interviews) and the construction and use of qualitative research tools (elaboration, conduction and analysis of semi-structured interviews; in-depth interviews; focus groups).

I can write research reports in Italian and English, and I have written several scientific articles both in Italian and English.

I have consolidated my educational/training skills by carrying out seminars and teaching activities with students both at academic and professional level.
